

ARB/C004/2020 – NEW FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 26th March 2020 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Claire L. Stafrace Zammit LL.D.). Compilation Number 137/2020 in the case:

(Inspector Kevin Pulis)

Versus

KURT MANUEL PACE, barber and pastizzar, 30 years, son of the late Carmel and Anna Manicolo, born in Pietà, Malta on the 13th January 1990, residing at Rudolph Mansions, Flat 9, Rudolph Street, Sliema and/or Allamanda, Flat 4, Bella Vista Street, San Gwann and holder of Maltese Identity Card bearing number 65190M.

ORDERED the attachment in the hands of third parties in general of all moneys and other movable or immovable property due to or pertaining or belonging to **KURT MANUEL PACE** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property, and this according to 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court AUTHORIZED the said accused to receive the amount authorized by law that does not exceed thirteen thousand, nine hundred and seventy-six Euro and twenty-four cents (€13,976.24) per year, after the accused indicates with a note from where they are perceiving this money.

Any person who acts in contravention of the court order mentioned in Section 22A and Section 23A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any property made in contravention of the said Court order shall be null and without effect at law.
