

ARB/C008/2020 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 25th November, 2020 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Donatella Frendo Dimech LL.D.). Compilation Number, 157/2020 in the case:

Versus

JAMES FENECH, company director, 41 years, son of the late Joseph and Mary Rose née Borg, born in Sydney, Australia on the 28th February 1979, residing at 341, Solaris, Triq l-Etna, Mellieħa and holder of Maltese Identity Card bearing number 519694M.

AND

SOVEREIGN CHARTERERS LIMITED, with Maltese registration number C 67113 and registered address at 21, Misrah il-Parroċċa, Mellieħa, Malta.

The Court AUTHORIZED the Transport Malta to accept the transfer of shares for the nautical vehicle registered with Maltese flag as mentioned in the decree dated 25th November, 2020. That one third of the shares shall be transferred and assigned to the accused **JAMES FENECH** and that another one third of the shares shall remain assigned to the society **SOVEREIGN CHARTERERS LIMITED**.

This variation is being published in terms of Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Victor Axiak LL.D) on the 24th April, 2020, which was published in the Government Gazette on the 30th April, 2020 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **JAMES FENECH** and **SOVEREIGN CHARTERERS LIMITED**.
