

ARB/C012/2022 – VARIATION OF SEIZING AND FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 3rd November, 2022 given by the Criminal Court – (Hon. Madam Justice Dr Consuelo Scerri Herrera LL.D.). In the case:

(Inspector Alfredo Mangion)

Versus

MURIEL MICALLEF, 42 years, daughter of Martin Micallef and Natalie Micallef née Galea, born in Pietà, Malta on the 28th September, 1980, and residing at Santa Marija, Flat 3, Triq Qrajten, Pietà and holder of Maltese Identity Card bearing number 443080M.

The Court AUTHORISES the accused MURIEL MICALLEF to withdraw moneys received from the Department of Social Security from the bank account listed in her name ending in-5051 and held at the HSBC Bank Malta plc. The amounts withdrawn shall be limited to the maximum annual amount of thirteen thousand, nine hundred and seventy-six Euro and twenty-four cents (€13,976.24).

This variation is being published in terms of Article 5 (3) of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta, Article 36 (4) of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, and Article 22A (3) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Monica Vella LL.D.) on the 11th February, 2022 which was published in the Government Gazette on the 23rd February, 2022 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **MURIEL MICALLEF**.
