

ARB/C020/2021 – NEW FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 23rd March, 2021 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Natasha Galea Sciberras LL.D.). Compilation Number 169/2021, in the case:

The Police
(Inspector Alfredo Mangion)

Versus

JUANITO JIMENEZ, construction worker, 27 years, son of Pedro Juan Jimenez and Pauline Deguara, born in Pietà, Malta on the 26th May, 1993, residing at 12, Sqaq id-Duluri Nru. 1, Hamrun and holder of Maltese Identity Card bearing number 242693M.

ORDERED the attachment in the hands of third parties in general of all moneys and other movable or immovable property due to or pertaining or belonging to **JUANITO JIMENEZ** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property, and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta, and Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta.

Any person who acts in contravention of the court order mentioned in Section 22A, Section 23A and Section 5 referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any property made in contravention of the said Court order shall be null and without effect at law.
