

ARB/C022/2022 – VARIATION OF A SEIZING AND FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 11th July, 2022 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Natasha Galea Sciberras LL.D.). Compilation Number 129/2022, in the case:

(Inspector Mark Anthony Mercieca)

Versus

HODON ADEN FARAH, unemployed, 42 years, daughter of the late Aden Farah and the late Anab Hussein, born in Somalia on the 1st February, 1980, and residing at 79, Flat 5A, Triq Sant' Antnin, Hamrun and holder of Maltese Identity Card bearing number 109785A.

The Court AUTHORIZES the accused HODON ADEN FARAH to receive the sum of three hundred and twenty-eight Euro and thirty-two cents (€328.32) representing amount due from the Housing Authority as listed within the mentioned Court decree. That this sum must form part of the annual amount of thirteen thousand, nine hundred and seventy-six Euro and twenty-four cents (€13,976.24) per year that the accused is entitled to perceive as per law.

This variation is being published in terms of Article 36 (4) of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta and Article 22A (3) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Natasha Galea Sciberras LL.D.) on the 21st March, 2022, which was published in the Government Gazette on the 1st April, 2022 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **HODON ADEN FARAH**.
