

ARB/C037/2022 – FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 30th May, 2022 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Natasha Galea Sciberras LL.D.). Compilation Number 159/2022, in the case:

Versus

RANSDON DEBONO, 18 years, son of Alan and Tiziana née Falzon, born in Pietà, Malta on the 28th October, 2003, residing at 67, 'Deo Gratias', Triq San Bartolomew, Qormi and holder of Maltese Identity Card bearing number 393003L.

ORDERED the attachment in the hands of third parties in general of all moneys and other movable property due to or pertaining or belonging to **RANSDON DEBONO** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property, and this in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

Any person who acts in contravention of the court order as mentioned in Article 22A and Article 23A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any property made in contravention of the said Court order shall be null and without effect at law.
