AND

**KURT MUSCAT;**

**The Court AUTHORISED the accused MARQUITA FARRUGIA** to carry out payments for the renewal of the insurance policy and road license for the vehicle held in the name of the accused as mentioned in the application dated 1<sup>st</sup> February, 2023. That these payments shall be deducted from the annual amount that the accused **MARQUITA FARRUGIA** is entitled to perceive.

This variation is being published in terms of Article 5 (3) of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Gabriella Vella LL.D.), on the 2<sup>nd</sup> November, 2020 which was published in the Government Gazette on the 5<sup>th</sup> November, 2020 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **MARQUITA FARRUGIA** and **Kurt Muscat**.
