**NAZZARENO SIVE RENO GRECH**, 67 years, son of Joseph and of the late Mary Concetta nee' Bugeja, born in Cospicua Malta on the 08<sup>th</sup> August 1954, residing at Elia House, Canon Road, Qormi Malta and holder of Maltese Identity Card bearing number 629254(M).

**The Court ORDERED** the general interdiction, also the interdiction to serve as a witness, except before the Courts of Justice, and as an architect, in any case and this for a period of ten (10) years starting from judgement date of the said **Nazzareno sive Reno Grech** and this according to section 109 of Chapter 9 of the Laws of Malta.
