

ARB/C004/2018 – NEW FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 3rd September, 2018 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Marse-Ann Farrugia LL.D.). Compilation Number 549/2018 in the case:

Versus

MIRIAM CARUANA, 34 years, cleaner, daughter of Sally (Salvina) *née* Caruana, born in Pietà, Malta on the 20th November 1983, residing at 35, Triq il-Gendus, Valletta and holder of Maltese Identity Card bearing number 0014784(M).

ORDERED the attachment in the hands of third parties in general of all moneys and other movable property due to or pertaining or belonging to **MIRIAM CARUANA** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Article 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

Any person who acts in contravention of the court order mentioned in Article 5 and Section 23A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any immovable property made in contravention of the said Court order shall be null and without effect at law.
