

ARB/C013/2018 – NEW FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 12th November, 2018 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Donatella Frendo Dimech LL.D.). Compilation Number 131/2018 in the case:

Versus

KSENIJA KOJOVIC, 34 years, unemployed, daughter of the late Ljubomir and Slavica née Brakocevic, born in Smederevo, Serbia on the 22nd December 1983, residing at Lunar Court, Flat 3, Triq Sant' Antnin, St. Paul's Bay and holder of Serbian Passport bearing number 012923618 and Maltese Identity Card bearing number 174183(A).

ORDERED the attachment in the hands of third parties in general of all moneys and other movable property due to or pertaining or belonging to **KSENIJA KOJOVIC** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

Any person who acts in contravention of the court order mentioned in Section 23A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any immovable property made in contravention of the said Court order shall be null and without effect at law.

Kull persuna li tagħmel xi haġa bi ksur tal-ordni tal-Qorti msemmi f'Artikolu 23A tkun hatja ta' reat u teħel meta tinstab hatja multa ta' mhux iżjed minn hdax-il elf, sitt mija u sitta u erbghin Euro u sebgħa u tmenin ċenteżmu (€11,646.87) jew prigunerija għal żmien ta' mhux iżjed minn tnax-il xahar, jew dik il-multa u prigunerija flimkien.
