

ARB/C015/2019 – NEW FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 14th March, 2019 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr Audrey Demicoli LL.D.). In the case:

Versus

LUKE FARRUGIA, 31 years, son of David and Maria Regina née Mazzelli, born in Pietà, Malta on the 22nd November 1987, residing at 10, Triq Sir Charles Cameron, Gzira, Malta and holder of Maltese Identity Card bearing number 530087(M).

ORDERED the attachment in the hands of third parties in general of all moneys and other movable or immovable property due to or pertaining or belonging to **LUKE FARRUGIA** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

Any person who acts in contravention of the court order mentioned in Section 23A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any immovable property made in contravention of the said Court order shall be null and without effect at law.
