

**ARB/C017/2019 – NEW FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 15<sup>th</sup> March, 2019 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Charmaine Galea LL.D.). Compilation Number 158/2019 in the case:

The Police  
(Inspector Joseph Xerri)

Versus

**ALEKSANDAR PETROVSKI**, plasterer, 42 years, son of Hristov and Savka née Spirova, born in Skopje, Macedonia on the 26<sup>th</sup> January 1977, residing at Flat 10, Teal Court, Triq Santa Venera, Msida, and holder of Bulgarian Identity Card bearing number 182639178 and personal number 7701263888.

**ORDERED** the attachment in the hands of third parties in general of all moneys and other movable or immovable property due to or pertaining or belonging to **ALEKSANDAR PETROVSKI** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

**The Court AUTHORIZED** the said accused to receive the amount that does not exceed thirteen thousand, nine hundred and seventy-six Euro and twenty-four cents (€13,976.24) per year after the accused indicates with a note from where they are perceiving this money.

Any person who acts in contravention of the court order mentioned in Section 22A and Section 23A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any immovable property made in contravention of the said Court order shall be null and without effect at law.
