

**ARB/C021/2019 – NEW FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 28<sup>th</sup> March 2019 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Josette Demicoli LL.D.). Compilation Number 188/2019 in the case:

Versus

**CHUKWUEBUKA EMMANUEL MBONU**, student, 24 years, son of Emmanuel Mbonu and Veronice Mbonu née Obu, born in Lagos, Nigeria on the 22<sup>nd</sup> December 1994, residing at Binja Misrah, Ent. A, Fl. 10, Triq Ismek Tifhirek, San Gwann and holder of Nigerian passport A50547201.

**ORDERED** the attachment in the hands of third parties in general of all moneys and other movable or immovable property due to or pertaining or belonging to **CHUKWUEBUKA EMMANUEL MBONU** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Article 5 of Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta, and Section 23A (2) of the Criminal Code, Chapter 9 of the Laws of Malta.

**The Court AUTHORIZED** the said accused to receive the amount authorized by law which is thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) on an annual basis provided that every financial entity is ordered to present a note by which it informs the Court in which account or from which account these moneys are taken or the accused themselves may indicate to the Court from which account they are perceiving the moneys indicated.

Any person who acts in contravention of the court order mentioned in Article 5 and Section 23A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any immovable property made in contravention of the said Court order shall be null and without effect at law.
