

CANCELLATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that following judgement dated 30th November, 2022 given by the Constitutional Court as presided by S.T.O Chief Justice Mark Chetcuti, Hon. Mr Justice Giannino Caruana Demajo and Hon. Mr Justice Anthony Ellul. Judgement Case Number 370/2022/1, in the case:

SEBASTIAN DALLI, 66 years, son of Carmel Dalli and Emma Dalli née Bonnici, born in Qormi, Malta on the 13th November, 1956 with the last known address of 16, Papillon, Triq 1-20 ta' Jannar, Qormi and holder of Maltese Identity Card bearing number 769956M.

Versus

The State Advocate and Attorney General

The Court CONFIRMS THE CANCELLATION of the freezing order of all the assets of the accused **SEBASTIAN DALLI**, which order was given through the decree dated 3rd February, 2009 by the Court of Magistrates (Malta) as a Court of Criminal Inquiry presided by Magistrate Dr Anthony G. Vella LL.D. in the case *The Police (Superintendent J.J. Fenech) vs Sebastian Dalli* which was duly published in the Government Gazette on the 13th February, 2009.

This judgement is confirming the final sentence delivered by the Civil Court, First Hall (Constitutional Jurisdiction) dated 22nd March, 2022 and which was appealed by the State Attorney and the Attorney General through their application dated 11th April, 2022.

This notice is being published in terms of Article 22A (6) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta.
