

ARB/C008/2023 – FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 3rd March, 2023 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Rachel Montebello LL.D.). Compilation Number 178/2023, in the case:

The Police
(Inspector John Leigh Howard)
(Inspector Mark Anthony Mercieca)

Versus

PATRICK MERCIECA, director, 43 years, son of Carmelo Mercieca and Maria Concetta Mercieca née Aquilina, born in Pietà, Malta on the 23rd June, 1979 and residing at 41, ‘Silhouette’, Triq il-Pellegrinaġġ tar-Roti, Żabbar and holder of Maltese Identity Card bearing number 304779M.

ORDERED the attachment in the hands of third parties in general of all moneys and other movable property due to or pertaining or belonging to **PATRICK MERCIECA** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property, and this in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court AUTHORIZED the said accused to receive the amount of thirteen thousand, nine hundred and seventy-six Euro and twenty-four cents (€13,976.24) per year, after the accused indicates with a note from where he is perceiving this money.

Any person who acts in contravention of the court order mentioned in Article 22A and Article 23A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand, six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any property made in contravention of the said Court order shall be null and without effect at law.
