

ARB/C010/2022 – VARIATION OF SEIZING AND FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 7th March, 2023 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Natasha Galea Sciberras LL.D.), Compilation Number 64/2022, in the case:

The Police
(Inspector Alfredo Mangion)

Versus

KEVIN MIFSUD, employed, 40 years, son of Saviour and the Salvina née Pace, born in Pietà, Malta on the 19th November, 1982, and residing at Water Lily, Triq Karmen Mikallef Buhagar, Żebbuġ, Malta and holder of Maltese Identity Card bearing number 630382M.

The Court AUTHORIZED the accused KEVIN MIFSUD to pay the sum of five hundred and thirty-one Euro and thirty-one cents (€531.31) to MelitaUnipol Insurance Agency Limited representing the renewal of the insurance policy and road license for the vehicle held in the name of the accused, as mentioned in the Court decree dated 7th March, 2023. This payment must be carried out from the bank account registered in the name of a third party ending in -7042 and held at the Bank of Valletta plc.

This variation is being published in terms of Article 36 (4) of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, Article 22A (3) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and Article 5 (3) of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta, following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Natasha Galea Sciberras LL.D) on the 14th February, 2022 which was published in the Government Gazette on the 22nd February, 2022 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **KEVIN MIFSUD**.
