

ARB/C012/2023 – SEIZING AND FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 21st December, 2022 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr Gabriella Vella LL.D.) which was confirmed by decree dated 27th March, 2023 given by the same Court – (Magistrate Dr Elaine Mercieca LL.D.). Compilation Number 8136/2022, in the case:

The Police
(Inspector Alfredo Mangion)

Versus

SHERIDAN LEE GRECH, 24 years, son of Charmaine Grech, born in Fgura, Malta on the 6th January, 1999, without a fixed address in Malta and holder of Maltese Identity Card bearing number 58199M.

ORDERED the attachment in the hands of third parties in general of all moneys and other movable property due to or pertaining or belonging to **SHERIDAN LEE GRECH** and prohibits the accused from transferring, pledging, hypothecating or otherwise changing or disposing of any immovable or movable property owned or otherwise held by him, and this in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and Article 36 of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta.

The Court AUTHORIZED the said accused to receive the amount of thirteen thousand, nine hundred and seventy-six Euro (€13,976.00) per year, after the accused indicates with a note from where he is perceiving this money.

Any person who acts in contravention of the Court order as mentioned in Article 22A and Article 36 referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding twelve thousand Euro (€12,000), or to imprisonment for a period not exceeding twelve (12) months, or to both such fine and imprisonment.

Any transfer or other disposal of any property made in contravention of the said Court order shall be null and without effect at law.
