

## **ARB/C014/2023 – SEIZING AND FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 17<sup>th</sup> April, 2023 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Rachel Montebello LL.D.). Compilation Number 592/2022, in the case:

Versus

**CLINT LA ROSA**, businessman, 35 years, son of Marco La Rosa and Rosaria La Rosa née Fenech, born in Pietà, Malta on the 30<sup>th</sup> November, 1987 and residing at 21, Mark Court, Flat 9, Triq ta' Gidwet, Marsaskala and holder of Maltese Identity Card bearing number 538587M.

**ORDERED** the attachment in the hands of third parties in general of all moneys and other movable property due to or pertaining or belonging to **CLINT LA ROSA** and prohibits the accused from transferring, pledging, hypothecating or otherwise changing or disposing of any immovable or movable property owned or otherwise held by him, and this in terms of Article 36 of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta and Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

Any person who acts in contravention of the Court order as mentioned in Article 36 and Article 23A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding twelve thousand Euro (€12,000), or to imprisonment for a period not exceeding twelve (12) months, or to both such fine and imprisonment.

Any transfer or other disposal of any property made in contravention of the said Court order shall be null and without effect at law.
