**The Court AUTHORIZES** the payment of the sum of four hundred, forty-one Euro and seventy-eight cents (€441.78) in favour of a third party's employment with the firm *Christopher Baldacchino & Associates* to be carried out from the current account held in the name of the mentioned firm ending in –1470 with Bank of Valletta plc.
