**YORGEN FENECH**, director, 42 years, son of the late George and Patricia née Camilleri, born in Tal-Pietà, Malta on the 23<sup>rd</sup> November 1981, residing at Portomaso, 2592, Vjal Portomaso, San Ġiljan and holder of Maltese Identity Card bearing number 36482M.

**The Court ORDERED THE CANCELLATION** of the seizing and freezing order of all the assets of the said **YORGEN FENECH** which order was given by the Courts of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Audrey Demicoli LL.D.) by a decree dated 30<sup>th</sup> November, 2019, and which was duly published in the Government Gazette of the 2<sup>nd</sup> December, 2019.
