**The Court AUTHORISED ALAN HARMSWORTH** to pay the sum of €782.30 for the renewal of the motor vehicle insurance policy for the vehicle mentioned in the court decree dated 12<sup>th</sup> September 2025, held by Elmo Insurance Limited from the bank account registered in the name of a third party ending in -0705 and held with Bank of Valletta plc..
