

## **ARB/C024/2021 – VARIATION OF SEIZING AND FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 10<sup>th</sup> September, 2025 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Leonard Caruana LL.D.). Compilation Number 199/2021, in the case:

The Republic of Malta

Versus

**SPIRIDIONE GOODLIP**, employee, 44 years, son of the late William and Carmen née Hill, born in Tal-Pietà, Malta on the 18<sup>th</sup> June, 1981, residing at 30, Lauredai, Triq il-Kurunell Cocks, Pembroke and holder of Maltese Identity Card bearing number 323081M.

**The Court ORDERS** the release of the property including also the immovable property situated in St Paul's Bay with the address as listed in the Court decree dated 10<sup>th</sup> September 2025, from the seizing and freezing order issued on **SPIRIDIONE GOODLIP** with the exception of the sum of thirty thousand Euro (€30,000) that presently is deposited in the bank account held by the Director of the Asset Recovery Bureau and that such sum shall be kept deposited in this bank account as stipulated by law.

**The Court further ORDERS** the release of all the bank accounts registered in the name of **SPIRIDIONE GOODLIP** and held by the Bank of Valletta plc, from the seizing and freezing order.

This variation is being published in terms of Article 36 (4)(a) of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Donatella Frendo Dimech LL.D.) on the 13<sup>th</sup> April, 2021 which was published in the Government Gazette on the 16<sup>th</sup> April, 2021 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **SPIRIDIONE GOODLIP**.
