

**ARB/C026/2021 – CANCELLATION OF A FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 1<sup>st</sup> September, 2025 given by the Court of Criminal Appeal – (Hon. Madame Justice Dr Consuelo Scerri Herrera LL.D.). In the case:

The Republic of Malta

Versus

**MATTHEW AZZOPARDI**, police officer, 47 years, son of Edmond and Esmeralda née Portelli, born in England on the 7<sup>th</sup> July, 1978, and residing at 3, Triq ir-Rixtellu, Luqa and holder of Maltese Identity Card bearing number 594178M.

**The Court ORDERED THE CANCELLATION** of the freezing order of all the assets of the said **MATTHEW AZZOPARDI** which order was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Rachel Montebello LL.D.) by a decree dated 6<sup>th</sup> July, 2020 which was duly published in the Government Gazette of the 23<sup>rd</sup> April, 2021.

**The court AUTHORISES** the release of the schedule of deposit in the amount of two thousand twenty-two Euro and eleven cents (€2,022.11).
