The Court AUTHORIZES Mapfre MSV Life plc to receive the payment of €480 on the policy with reference number FP465562 (Legacy Comprehensive with Profits) from the bank account registered in the name of **TIMOTHY GALEA** ending in -0017 and held at APS Bank plc. That such payment shall form part of the annual amount of €21,945 which the accused is entitled to perceive from the bank account ending in -0017.

The Court further AUTHORIZES APS Bank plc to release this sum to Mapfre MSV life plc for the renewal of the said policy.

That in case the premium payment of this policy is incurred annually, this court authorisation for the execution of these expenses shall remain valid and applicable each time these payments are due, from the bank account ending in -0017 and held with APS Bank plc, without the need to submit an application every time these expenses arise.

This variation is being published in terms of Article 36 (5) of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Noel Bartolo LL.D.) on the 10th July, 2024 which was published in the Government Gazette on the 19th July, 2024 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **Jonathan Mizzi, Greta sive Greta Josephine Mizzi, Otman Ali Otman Abdulkader, Akakus International Ltd, Convey Shipping & Trading Agency Ltd, Duncan Mangion, Carmel Busuttil, TIMOTHY GALEA, Jonathan Theuma, Edward Mifsud and Marica Bugeja.**
