

**ARB/C061/2025 – VARIATION OF SEIZING AND FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 16<sup>th</sup> September, 2025 given by the Criminal Court – (Hon Dr Natasha Galea Sciberras LL.D.), in the case:

The Republic of Malta

Versus

**LUCIANO CURTI;**

**CD LIFTS LIMITED;**

AND

**DANIEL ELLUL SULLIVAN**, salesman, 54 years, son of the late Roger Ellul Sullivan and Marcellina Ellul Sullivan née Fava, born in Sliema, Malta on the 17<sup>th</sup> January, 1971 and residing at ‘Phyllis’, Blk J, Triq Giovanni Barbara, Hamrun and/or ‘Penthouse’, Sqaq is-Sigra, St. Julian’s and holder of Maltese Identity Card bearing number 45671M.

**The Court AUTHORISED DANIEL ELLUL SULLIVAN** to perceive the amount established by the Minister by order in the Government Gazette of Malta No. 21,191 through Legal Notice 31 of 2024 – *Establishment of Maximum Amount which may be Released to Persons who are Subject to Attachment Orders or to Seizing and Freezing Orders under the Proceeds of Crime Act Order, 2024*, of twenty-one thousand, nine hundred and forty-five Euro (€21,945) annually as the maximum amount. That this payment shall be made from the salary due to him from his employment, and from the bank account registered in his name ending in -0042 and held at the Bank of Valletta plc.

This variation is being published in terms of Article 36 (4)(a) of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Lara Lanfranco Law LL.D.) on the 5<sup>th</sup> May, 2025 which was published in the Government Gazette on the 9<sup>th</sup> May, 2025 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **Luciano Curti, Cd Lifts Limited**, and **DANIEL ELLUL SULLIVAN**.

**Il-Qorti AWTORIZZAT lil DANIEL ELLUL SULLIVAN** li jipperċepixxi l-ammont stabbilit mill-Ministru b’ordni fil-Gazzetta tal-Gvern ta’ Malta Nru. 21,191 permezz tal-Avviż Legali 31 tal-2024 – *Ordni tal-2024 li Jistabbilixxi l-Ammont Massimu Rilaxxjabbli lil Persuni li jkunu Soġġetti għal Ordnijiet ta’ Sekwestru jew għal Ordnijiet ta’ Qbid u Iffriżar taħt l-Att dwar ir-Rikavat mill-Kriminalità*, ta’ wieħed u għoxrin elf, disa’ mija u ħamsa u erbgħin Euro (€21,945) kull sena bħala l-ammont massimu. Dan il-ħlas għandu jsir mill-paga dovuta lil mill-impjeg tiegħu, u mill-kont bankarju intestat f’ismu li jispiċċa -0042 miżmum mal-Bank of Valletta plc.
