CANCELLATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated the 16th of October 2025, issued by the Court of Criminal Appeal as per the Honourable Justice Madam Natasha Galea Sciberras B.A., LL.D., in appeal number 68/2013 in names:

The Court ORDERED THE CANCELLATION of the freezing order of all the assets of the said **Francis Apap**, which order was given by the Court of Magistrates (Gozo) as a Court of Criminal Judicature (Magistrate Dr Neville Camilleri) by a decree dated 27th January 2015 which was duly published in the Government Gazette of the 3rd of February 2015.
