IT IS BEING NOTIFIED that by a decree dated 30th October, 2025 given by the Criminal Court – (Hon. Judge Dr Natasha Galea Sciberras LL.D.). In the case:

MICHAEL HEARN, 40 years, son of Gary George and Stephanie née Pace, born in Barking and Dagenham, England on the 24th June, 1985, residing at 4 St Stephen Crt, Blk F, Fl 3, Triq is-Snajja, Msida, and holder of a Maltese Identity Card bearing number 748518L and British Passport bearing Number 537050200.

The Court AUTHORIZED MICHAEL HEARN to pay to Laferla Insurance Agency Ltd the sum of five hundred and eleven Euro and fifty-three cents (€511.53), representing two hundred and fifty-two Euro and fifty-three cents (€252.53) for the insurance premium and two hundred and fifty-nine Euro (€259) for the road license of the vehicle mentioned in the Court decree dated 30th October 2025. Such payment shall be made from the bank account registered in the name of Michael Hearn, ending in -9724 and held with Bank of Valletta plc.

This variation is being published in terms of Article 22A (3) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Monica Vella LL.D) on the 15th June, 2019 which was published in the Government Gazette on the 20th June, 2019 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **MICHAEL HEARN**.
