

ARB/C066/2020 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 23rd October, 2025 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Leonard Caruana LL.D.). Compilation Number 686/2020, in the case:

The Republic of Malta

Versus

JASON VELLA TABONE;

PIERRE GRECH CUMBO PILLOW, businessman, 49 years, son of Augustine and Helen née Buhagiar, born in Attard, Malta on the 24th July, 1976, and residing at Blue Harbour Shackleton, Fl A2, Ix-Xatt ta' Xbiex, Ta' Xbiex and holder of Maltese Identity Card bearing number 362376M.

AND

PGP TRADING LIMITED;

The Court AUTHORISED PIERRE GRECH CUMBO PILLOW to pay the sum of four hundred thirty-six euro and fifty cents (€436.50) to Bonnici Insurance Agency Limited in respect of the vehicle mentioned in the Court decree dated 23rd October, 2025, which amount represents the insurance policy bearing number P21332590-25, as well as the road license of the same vehicle. This amount shall be deducted from the sum annually perceived by Pierre Grech Cumbo Pillow.

That this Court authorisation for making these payments shall remain valid and applicable each time these payments are due, without the need to submit an application every time these payments are encountered. Such payments shall be deducted from the amounts annually receivable by **PIERRE GRECH CUMBO PILLOW**. Should this vehicle be replaced, the authorisations herein granted shall automatically cease to apply (*ipso jure*), and Pierre Grech Cumbo Pillow shall be required to submit a new application.

This variation is being published in terms of Article 36 (5) of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Nadine Lia LL.D) on the 9th December, 2020, which was published in the Government Gazette on the 24th December, 2020 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **Jason Vella Tabone, PIERRE GRECH CUMBO PILLOW**, and **PGP Trading Limited**.
