

DKR 498/2015 - CANCELLATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 17th December, 2025 given by the Criminal Court of Appeal (Superior Court) – (Hon. Chief Justice Dr. Mark Chetcuti, Hon. Judge Dr. Edwina Grima and Hon. Judge Dr. Giovanni M. Grixti LL.D) after an application filed by Jonathan Roger Portelli on the 10th of December, 2025 and following judgement dated 26th November 2025, Bill of Indictment Number 14/2018, in the case in the names:-
