IT IS BEING NOTIFIED that by a decree dated 18th November 2025 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr Nadine Sant Lia LL.D.). Compilation Number 339/2019, in the case:

PATRICK CUTAJAR, 45 years, son of the late Victor and Dolores née Camenzuli, born in Pietà, Malta on the 17th Decenmber 1973, residing at 33, Pour l’Infinite, Triq Il-Germanja, Naxxar, and holder of a Maltese Identity Card bearing number 16274(M).

The Court ORDERED that the Seizing and Freezing order issued on 1th June 2019 against **PATRICK CUTAJAR** is being limited to the sum of two thousand, six hundred and ten Euros (€2,610).

This variation is being published in terms of Section 5 (3) of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and Article 36 (4) of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Donatella Frendo Dimech LL.D.) on the 13th April, 2021 which was published in the Government Gazette on the 16th April, 2021 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **PATRICK CUTAJAR**.
