IT IS BEING NOTIFIED that by a decree dated 17th December, 2025 given by the Court of Magistrates (Gozo) as a Court of Criminal Judicature – (Magistrate Dr Jean Paul Grech LL.D.). Compilation Number 52/2025, in the case:

ANTHONY SAID, employed, 51 years, son of the late Peter Said and the late Carmela Said née Vella, born in Gozo, on the 22nd March, 1974 and residing at 153, Pjazza San Girgor, Kercem, Gozo and/or “St.Mary” Triq L-Isptar San Giljan, il-Fontana, Gozo and holder of a Maltese Identity Card bearing number 08474G.

The Court AUTHORISED ANTHONY SAID to proceed with the sale of his share in the immovable property situated at house number eight (8), Triq ir-Rabat, Marsalforn, Żebbuġ, Gozo, subject to the conditions mentioned in the Court decree dated 17th December, 2025.

This variation is being published in terms of Article 22A (3) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and Article 36 (5) of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Judicature (Magistrate Dr Simone Grech LL.D.) on the 16th July, 2025, which was published in the Government Gazette on the 22nd July, 2025 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **ANTHONY SAID**.
