

DKR 308/2012 – CANCELLATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 22nd January, 2026 given by the Criminal Court – (Hon. Judge Dr. Aaron Bugeja LL.D) after an application filed by Marlon Apap on the 13th January, 2026 and following judgement given by the same Court on the 27th February 2023, Bill of Indictment number 6/2017, in the case in the names:-

MARLON APAP, 48 years, son of Victor and Angelica nee' Vella, born in Pieta' Malta on the 02nd September 1977, residing at number 38, *Merħba*, Triq Amleto Spiteri, Qormi Malta and holder of Maltese Identity Card bearing number 459977(M).

The Court ORDERED THE CANCELLATION of the freezing order of all the assets of the said **Marlon Apap** which order was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Mirima Hayman LL.D) by a decree dated 13th November, 2012 and published in the Government Gazette of the 16th November, 2012.
