The Court ORDERED THE CANCELLATION of the seizing and freezing order issued on the assets of **ANDREW AGIUS** which order was given by the Criminal Court – (Hon. Judge. Dr Aaron M. Bugeja LL.D.) by a decree dated 20th May, 2022 which was duly published in the Government Gazette of the 5th February, 2026 and declared that the said order is no longer in force, the matter having become *res judicata*.
