**IT IS BEING NOTIFIED** that by a decree dated 23<sup>rd</sup> January, 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Leonard Caruana LL.D.). Compilation Number 213/2022, in the case:
