

ARB/C023/2026 – FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 03rd March 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Lara Lanfranco LL.D.), with Compilation Number 10467/2025, in the case:

The Republic of Malta

Versus

DYLAN SCHEMBRI, 31 years, son of Emanuel Schembri and Josephine Schembri nee' Xuereb, born in tal-Pieta' Malta, on the 8th March 1994, and residing at 47, 'Anson', Flat 1, Triq il-Fuhharin, Birkirkara, and holder of a Maltese Identity Card bearing number 128094M.

The Court ORDERED the attachment in the hands of third parties in general of all moneys and other movable property due to or pertaining or belonging to **DYLAN SCHEMBRI** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property, and this in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court AUTHORIZED the said accused to receive the amount of thirteen thousand, nine hundred and seventy-six Euro and twenty-four cents (€13,976.24) per year, after declaring the sources, monies and other modalities of income, including salary, wages, pension and social benefits paid to him.

Any person who acts in contravention of the court order mentioned in Article 22A and Article 23A, referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand, six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any property made in contravention of the said Court order shall be null and without effect at law.

II-Qorti AWTORIZZAT lill-imputat li jista' jibqa' jirċievi ammonti li ma jeccedux is-somma ta' tlethax-il elf disa' mija u sitta u sebgħin Euro u erbgħa u għoxrin ċenteżmu (€13,976.24) fis-sena, wara li jiddikjara l-ghejjun, il-mod u modalitajiet oħra ta' hlas, inkluz salarju, paga, pensjoni u beneficcji socjali li jithallsu lilu..
