

## ARB/C024/2025 – VARIATION OF A FREEZING ORDER

**IT IS BEING NOTIFIED** that by a decree dated 23<sup>rd</sup> December, 2025 given by the Criminal Court – (Hon. Judge Dr Neville Camilleri LL.D.), in the case:

The Republic of Malta

Versus

**SEAN ATTARD**, security, 30 years, son of Dorianne Attard née Attard, born in Tal-Pietà, Malta on the 14<sup>th</sup> April, 1994, and residing at 49, Block A, Flat 6, Triq l-Indipendenza, Żebbug, Malta and holder of a Maltese Identity Card bearing number 182394M.

**CARLOS PACE;**

**YOUSEF ESSESI;**

AND

**CLEAVEN PACE;**

**The Court AUTHORISED** that there is nothing preventing the vehicle belonging to a third party, as mentioned in the application filed by **SEAN ATTARD** on the 19<sup>th</sup> December 2025, from being covered by an insurance policy while being driven by **SEAN ATTARD**, provided that the said vehicle remains subject to the effects of the Seizing and Freezing Order and to confiscation should it be used for criminal purposes.

This variation is being published in terms of Article 22A (3) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Leonard Caruana LL.D) on the 26<sup>th</sup> February, 2025, which was published in the Government Gazette on the 7<sup>th</sup> March, 2025 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **SEAN ATTARD, CARLOS PACE, YOUSEF ESSESI** and **CLEAVEN PACE**
