

## **ARB/C026/2025 – VARIATION OF A FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 23<sup>rd</sup> February, 2026 given by the Criminal Court – (Hon. Judge Dr Edwina Grima LL.D.), in the case:

The Republic of Malta

Versus

**LIAM STEWART**, installer, 24 years, son of Bruce Donald Stewart and Lily Anna Stewart née Busuttil, born in Tal-Pietà, Malta on the 7<sup>th</sup> October, 2001, and residing at 1, App. Yacht Marina, Block 4, Flat 3, Triq Qrajten, Tal-Pietà, Malta and holder of a Maltese Identity Card bearing number 398801L.

**The Court AUTHORISED LIAM STEWART** to pay all arrears due to date in relation to the loan account held with HSBC Bank Malta plc, and further authorised that the monthly payments in the amount of one hundred ninety-three Euro and sixty-eight cents (€193.68) shall continue to be paid from the bank account held in the name of the third party mentioned in the Court decree dated 23<sup>rd</sup> February 2026 ending in -0648 and held with Bank of Valletta plc.

This variation is being published in terms of Article 22A (3) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Elaine Rizzo LL.D) on the 27<sup>th</sup> February, 2025, which was published in the Government Gazette on the 11<sup>th</sup> March, 2025 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **LIAM STEWART**
