

ARB/C031/2026 – FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 27th March 2026, given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Claire L. Stafrace Zammit LL.D.). Compilation Number 1961/2026, in the case:

The Republic of Malta

Versus

KYLE MICALLEF, 23 years, son of Felix Micallef and Joan Vella, born in Pietà, Malta on the 9th August 2002, and residing at 71, Zinnia, Flat 1, Triq il-Gudja, Hal-Għaxaq and holder of Maltese Identity Card, bearing number 283102L with registered address at 48, Triq San Gorg, Bormla, Malta.

The Court is ordering the seizing and/or retaining in the hands of third parties, in a general manner, all monies and all movable or immovable property that are due to, or belong to **KYLE MICALLEF**, or relate to the accused or are his property. It also prohibits the accused from transferring, promising, mortgaging, exchanging, or otherwise disposing of any movable or immovable property that is his or held by him, in terms of Article 23A of the Criminal Code and Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta.

The Court Orders the freezing of assets, except for those established by law, namely thirteen thousand nine hundred and seventy-six euro and twenty-four cents (€13,976.24).

Any person who acts in contravention of the Court order as mentioned in Article 23A and Article 22A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any property made in contravention of the said Court order shall be null and without effect at law.
