

**ARB/C128/2025 – VARIATION OF SEIZING AND FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 25<sup>th</sup> March, 2026 given by the Criminal Court – (Hon. Judge Dr Neville Camilleri LL.D.), in the case:

The Republic of Malta

Versus

**MICHAEL EBEJER;**

**ALOYSIA ISABELLA EBEJER;**

AND

**CHARLES EBEJER**, gardener, 29 years, son of Michael Ebejer and Aloysia Isabella Ebejer nee' Aquilina, born in Pietà, on the 12<sup>th</sup> October, 1996, residing at 85, Apple Tree Crt Flat 4, Triq is-Sibi, Kalkara and holder of a Maltese Identity Card bearing number 430396M.

**The Court AUTHORISES CHARLES EBEJER** to carry out the following payments from the bank account held at the Bank of Valletta Plc in the name of Charles Ebejer:

- a) Payment of the arrears due on the loan account in the name of Charles Ebejer ending in -3180 and held at the BOV plc., in the amount of €1,750, together with monthly repayments of €421.75.
- b) Payment of the arrears due on the loan account in the name of Charles Ebejer ending in -2236 and held at the BOV plc., in the amount of €292, together with monthly repayments of €57.77.

**The Court further AUTHORISED** Bank of Valletta plc to receive the above mentioned payments from the funds held in the bank account registered in the name of Charles Ebejer.

**The Court further AUTHORISED CHARLES EBEJER** to pay the Home Block Policy with number 3522310100336 held by MAPFRE Middlesea in the amount of €108 annually, and the life policy with number 1032284DT held by MAPFRE MSV Life in the amount of €167.33 annually.

**The Court further AUTHORISED** Bank Of Valletta plc and MAPFRE MSV Life to carry out anything that may be required as ancillary to the above requests.

This variation is being published in terms of Article 36 of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Leonard Caruana LL.D.) on the 14<sup>th</sup> November, 2025 which was published in the Government Gazette on the 9<sup>th</sup> December, 2025 where the Court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **Michael Ebejer, Aloysia Isabella Ebejer and CHARLES EBEJER.**
