

ARB/C107/2025 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 9th February 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Lara Lanfranco LL.D.) Compilation number 767/2025, in the case:

The Republic of Malta

Versus

ANDREINA FENECH FARRUGIA;

GIOVANNI ELLUL, director, 39 years, son of Salvu Ellul and Rita Ellul nee' Sammut, born in Pieta', Malta, on the 23rd September 1986, residing in '126, Casa Bella Vista, Triq tax-Xerriek, Marsaxlokk' and holder of a Maltese Identity Card bearing number 452386M.

AND

MALTA FISH FARMING LIMITED;

The Court AUTHORIZED GIOVANNI ELLUL to transfer 2,100 ordinary (B) shares in the company ELL Invest, with a value of €2,100 (€1 per share), to his father Saviour, also known as Salvu Ellul. It also authorized him to transfer the one (1) ordinary share in ELL Finance, with a value of €1 (€1 per share), to ELL Invest, and for 700 new ordinary (A) shares in ELL Invest to be issued and transferred to Saviour Ellul, also known as Salvu, Ellul with a value of €700 (€1 per share). The Court also orders that these same shares shall remain subject to the freezing order issued by the Court of Magistrates (Malta) as a Court of Criminal Inquiry, dated 29th September 2025.

This variation is being published in terms of Section 5 (3) of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Rachel Montebello LL.D.), on the 29th September, 2025 which was published in the Government Gazette on the 7th October, 2025 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **GIOVANNI ELLUL**.
