IT IS BEING NOTIFIED that by a decree dated 26th March, 2026 given by the Criminal Court – (Hon. Judge Dr Neville Camilleri LL.D.), in the case:

The Republic of Malta

Versus

JASON FARRUGIA, self-employed, 38 years, son of Michael and Catherine née Baldacchino, born in Marsaxlokk, Malta on the 11th August, 1987, residing at 74, Soleil, Triq il-Port Ruman, Marsaxlokk and holder of Maltese Identity Card bearing number 355287M.

AND

CHRISTINE FARRUGIA;

The Court AUTHORISED JASON FARRUGIA to pay the annual amount of €320 to HSBC Life Assurance (Malta) Ltd, representing the premium due in respect of insurance policy number 300-002285, from the bank account held in the name of **JASON FARRUGIA**, ending in -0101 and held with BNF Bank plc.

This variation is being published in terms of Article 36 of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Yana Micallef Stafrace LL.D.) on the 25th May, 2022 which was published in the Government Gazette on the 31st May, 2022 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **JASON FARRUGIA** and **Christine Farrugia**.
