

## ARB/C041/2026 – SEIZING AND FREEZING ORDER

**IT IS BEING NOTIFIED** that by a decree dated 18th April 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr JP Grech LL.D.). Compilation Number 2568/2026, in the case:

The Republic of Malta

Versus

**MILOS RADOVIC**, employed, 36 years, son of late Milinko Radovic and late Radmilla nee' Kukic, born in Serbia, on the 23rd May 1989, and residing at Flat 2, Peprina Court 6, Triq Garcin, Msida, holder of Serbian Passport with number 017462858

**The Court is ordering** a “Seizure and Freezing Order” and is seizing, in the hands of third parties, in a general manner, all monies and movable property that are due to **MILOS RADOVIC** or that belong to him or are his property. It is also prohibiting the accused from transferring or otherwise disposing of any movable or immovable property, in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta.

**The Court is authorizing** that the accused may, for all reasonable purposes, receive annually the amount established by law of €13,976.24, from which must be specified the sources, manner, and other modalities of payment, including salary, wages, pension, and social benefits that are to be paid to the accused.

Any person who acts in contravention of the Court order mentioned in Article 22A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand, six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any property made in contravention of the said Court order shall be null and without effect at law.

**Il-Qorti qed tordna** “Ordni ta' Qbid u Friżar” u tissekwestra f'idejn terzi persuni b'mod ġenerali l-flejjes u l-propjetà mobbli kollha li jkunu dovuti lil **MILOS RADOVIC** jew ikunu jmissu lilu jew huma propjetà tiegħu, u tipprojbixxi lill-imputat milli jittrasferixxi jew xort oħra jiddisponi minn xi propjetà mobbli jew immobbli u dan ai termini tal- Artikolu 22A tal – Ordinanza dwar il-Mediċini Perikolużi Kap 101 tal – Ligijiet ta' Malta.

**Il-Qorti qed tawtorizza** li l-imputat jista', għal kull buon fini jipperċepixxi annwalment l-ammont previst mil-liġi ta' €13,976.24 minn fejn għandhom jiġu speċifikati l-għejjun, il-mod u modalitajiet oħra ta' hlas, inkluż salarju, paga, pensjoni u benefiċċji soċjali li jkun ser jithallsu lill-imputat

Kull persuna li tagħmel xi haġa bi ksur tal-ordni tal-Qorti msemmi fl-Artikolu 22A, tkun hatja ta' reat u tehel meta tinstab hatja multa ta' mhux iżjed minn hdax-il elf, sitt mija u sitta u erbgħin Euro u sebġha u tmenin ċenteżmu (€11,646.87) jew prigunerija għal żmien ta' mhux iżjed minn tnax-il xahar, jew dik il-multa u prigunerija flimkien.

Kull trasferiment ieħor jew tneħhija oħra ta' propjetà li jsiru bi ksur ta' dik l-ordni tal-Qorti jkunu nulli u ma jkollhom ebda effett fil-liġi.
