The Court ORDERED THE CANCELLATION of the freezing order issued on the assets of **MARC PAUL BRADLEY CRIMENI** which order was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Claire L. Stafrace Zammit LL.D.) by a decree dated 28th June, 2021 which was duly published in the Government Gazette of the 9th July, 2021 and declared that the said order is no longer in force, the matter having become *res judicata*.
