

ARB/C069/2025 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 4th March, 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Leonard Caruana LL.D.). Compilation Number 431/2025 in the case:

The Republic of Malta

Versus

SEAN GERADA, self-employed, 36 years, son of Grazjo Gerada and the late Djana Gerada née Spiteri, born in Tal-Pietà, Malta on the 26th February, 1990 and residing at 133, 'Naivasha', Triq il-Friefet, Marsaskala, and holder of Maltese Identity Card bearing number 138190M.

The Court AUTHORISED the release of funds in the amount of €5,000 (five thousand Euro) to the third party mentioned in the court decree dated 4th March 2026, representing funds deposited as a guarantee for travel purposes. Such funds shall be released to the said third party as the depositor thereof.

This variation is being published in terms of Article 22A (3) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Marse-Anne Farrugia LL.D) on the 17th May, 2025, which was published in the Government Gazette on the 23rd May, 2025 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **SEAN GERADA**.
