

ARB/C098/2024 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 23rd March, 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Gabriella Vella LL.D.). Compilation Number 982/2024, in the case:

The Republic of Malta

Versus

CHERISE CAMILLERI, police sergeant, 30 years, daughter of Leslie Camilleri and Maryann Camilleri née Felice, born in Tal-Pietà, Malta on the 4th February, 1996, residing at 21, 'Id-Dar tan-Nannu', Triq Correa, Qormi and holder of a Maltese Identity Card bearing number 67696M.

The Court AUTHORISED Bank of Valletta, to effect, on behalf of **CHERISE CAMILLERI**, the following payments from the bank account registered in her name ending in -9986 and held with Bank of Valletta plc, in favour of Peak Insurance Brokers, as follows;

- a) the amount of €216 (two hundred and sixteen Euro), representing the renewal of the licence of the vehicle mentioned in the Court decree dated 23rd March, 2026;
- b) the amount of €193.84 (one hundred and ninety-three Euro and eighty-four cents), representing the renewal of the insurance policy of the said vehicle.

The Court further AUTHORISED Peak Insurance Brokers to proceed with the renewal of the insurance policy and the road licence of the vehicle mentioned in the Court decree dated 23rd March, 2026.

This variation is being published in terms of Article 36 of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Victor G. Axiak LL.D.) on the 23rd November, 2024 which was published in the Government Gazette on the 29th November, 2024 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **CHERISE CAMILLERI**.
