

ARB/C138/2025 – VARIATION OF A SEIZING AND FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 9th March, 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Leonard Caruana LL.D.), with Compilation Number 998/2025, in the case:

The Republic of Malta

Versus

DYLAN VELLA, self-employed, 32 years, son of Anthony Vella and Melanie Vella nee' Camilleri, born in Pieta, on the 5th February, 1994, residing at Block 11, Door 13, Flat 7, Gardenja Street, Santa Lucija and holder of a Maltese Identity Card bearing number 86694M.

The Court AUTHORISED DYLAN VELLA to effect payment through the third party mentioned in the Court decree dated 9th March, 2026, of the amount of €1,241.80 to the Commissioner for Taxes, representing social security contributions and ancillary charges, including interest accrued to date, from the bank account ending in -3224 and held with Bank of Valletta plc.

This variation is being published in terms of Article 36 (4)(a) of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) Court of Criminal Inquiry (Magistrate Dr Leonard Caruana LL.D) on the 28th November, 2025 which was published in the Government Gazette on the 19th December, 2025 where the Court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **DYLAN VELLA**.
