

**ARB/C140/2025 – VARIATION OF A SEIZING AND FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 3<sup>rd</sup> March, 2026 given by the Criminal Court – (Hon. Judge Dr. Neville Camilleri LL.D.), with Compilation Number 897/2025, in the case:

The Republic of Malta

Versus

**THOMAS GATT**, 65 years, son of Michael Gatt and Mary Gatt nee' Caruana, born in Zabbar, on the 26<sup>th</sup> January, 1961, residing at 31, Morning Star, Triq Alessandru VII, Zabbar and holder of a Maltese Identity Card bearing number 122061M.

**The Court AUTHORISED THOMAS GATT** to pay the insurance premiums relating to the vehicles mentioned in the application dated 20<sup>th</sup> February 2026 in favour of Mapfre Middlesea p.l.c., that such payment shall be made from the bank account held in the name of **THOMAS GATT** ending in – 0100 and held by Lombard Bank Malta plc.

This variation is being published in terms of Article 36 (4) of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Leonard Caruana LL.D.) on the 26<sup>th</sup> November, 2025, which was published in the Government Gazette on the 23<sup>rd</sup> December, 2025 where the Court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **THOMAS GATT**.
