

ARB/C140/2025 – VARIATION OF A SEIZING AND FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 18th March, 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Leonard Caruana LL.D.), with Compilation Number 897/2025, in the case:

The Republic of Malta

Versus

THOMAS GATT, 65 years, son of Michael Gatt and Mary Gatt nee' Caruana, born in Zabbar, on the 26th January, 1961, residing at 31, Morning Star, Triq Alessandru VII, Zabbar and holder of a Maltese Identity Card bearing number 122061M.

The Court AUTHORISED THOMAS GATT to receive payment from GasanMamo Insurance, representing the necessary repairs to the vehicle mentioned in the Court decree dated 18th March, 2026, owned by him, provided that GasanMamo Insurance shall effect payment directly to the suppliers carrying out the said repairs.

This variation is being published in terms of Article 36 of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Leonard Caruana LL.D.) on the 26th November, 2025, which was published in the Government Gazette on the 23rd December, 2025 where the Court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **THOMAS GATT**.
