

DKR 252/2010 – CANCELLATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 30th August, 2023 given by the Criminal Court – (Hon. Dr. Edwina Grima LL.D) after an application filed by Angelo Bilocca on the 25th August, 2023 and following the execution of judgement given by the same court on the 14th of December 2017, Bill of Indictment number 4/2013, in the case in the names:-
