

**ARB/C010/2026 – VARIATION OF A SEIZING AND FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 4<sup>th</sup> May, 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Caroline Farrugia Frendo LL.D.), with Compilation Number 726/2026, in the case:

The Republic of Malta

Versus

**SAMUELE PERNICONE**, 35 years, son of Vittorio Rosso and Olanda Rosso, born in Messina, Italy on the 7<sup>th</sup> January, 1991, and residing at ‘Brighton Apartments, Flat 1, Tower Road, Sliema’ and holder of a Maltese Identification Card bearing number 189898A and an Italian Identity Card AZ1749097.

**The Court AUTHORISED SAMUELE PERNICONE**, once he finds regulated employment, to open a bank account with Maltese banks or financial institutions and to receive his salary in the said bank account, within the limit of not more than €13,976.24 (thirteen thousand, nine hundred and seventy-six Euro and twenty-four cents) annually

This variation is being published in terms of Article 22A (3) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, following a seizing and freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Court of Criminal Judicature (Magistrate Dr Kevan Azzopardi LL.D.) on the 28<sup>th</sup> January, 2026, which was published in the Government Gazette on the 13<sup>th</sup> February, 2026 where the Court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **SAMUELE PERNICONE**.
